

People often think that contacting their state legislators will not have any effect. On the contrary, legislators are very interested in what the public has to say. They are glad to hear from individuals in their district and see dialogue with the public as one of their primary objectives while in office. Effective methods of communication with your state lawmakers include letters, emails and even phone calls. A thoughtful, factual and timely letter or email can solidify or cause a serious review of a current issue and gives legislators a better understanding of issues and of public opinion.

When you introduce yourself, save time by making it clear who you are and what you are writing about. Be constructive in your communication. If you agree and support current actions, say so! If you disagree with the current approach to an issue, explain what you believe is the right approach. Legislators appreciate well-prepared facts and views, presented in a straight-forward manner.

Address your legislator properly. Know your legislator's full name and correct spelling.
